Admissions process

Applying to study with BSBI has never been easier! Here's how it works:

- 1. Create an account here: apply.berlinsbi.com
- 2. Select the programme and intake you would like to apply for;
- Complete all sections of the online application;
- Submit your application;
- 5. Our admissions team will liaise with you with regards to the next steps.

Once you have been accepted, you need to apply for a German student visa as soon as possible. To do this, you must:

- Make an appointment with the German embassy in your country and complete an application form (the administrative fees for this are usually around €60);
- Ensure that you provide all of the correct documents to avoid refusal. Your visa confirmation will take on average two to three months, depending on your country.

It should be noted that the student visa or 'Visum zu Studienwecken' only lasts three to six months, so you'll need to apply for a residence permit at the Foreigners Office before your visa expires. For more information on the visa process visit: **germany-visa.org/application-process**

Entry requirements

Minimum age

8 (titles awarded upon completion of at least 12 years of schooling)

Academic qualifications

A school leaving certificate that entitles you to higher education in Germany, for example, Abitur, Fachhochschulreife, Matura, International Baccalaureate, international school leaving certificates, BTEC/National Diploma or an Advanced Vocational Certificate of Education.

If you do not meet the above academic requirements, applicants with professional qualifications and / or four or more years of full-time work experience will be considered on an individual basis.

English language requirements

IELIS 6.0 (not less than 5.5 in any component), PTE 50 + score or equivalent.

The English proficiency test can be waived by the following candidates

- English native speakers;
- Applicants having completed their education in English, such as a High School diploma or IB.


